



Privacy Notice for Customers

IDENTITY AND ADDRESS OF THE CONTROLLER.

The entity responsible of the personal data that you provide is Network Information Center, S.A. de C.V. (commercially known as "Akky") with address at Av. Eugenio Garza Sada 427, Piso 2, Local 1, Col. Altavista, Monterrey, Nuevo León, México, ZIP 64840.

DEFINITIONS.

Akky provides you with a list of all the definitions of those words that will be used throughout this Notice so that you may have the utmost clarity in terms of content:

Cookies.

Fragments of information from a web page that are stored in a hard drive of the machine, used to connect to Internet through the page server.

IP Address.

Internet protocol address. It is a numerical identifier used by a device when connecting to Internet, which is assigned by the service provider at the time the connection is made.

Domain Name.

Represents a common identifier of a group of computers or equipment connected to a network. It is a simple internet addressing system designed to allow users to easily locate sites on internet. For the purposes of the present, it will only refer to the domain names under the cctld .MX.

Internet Resource.

IP Address Blocks and/or ASN numbers (Autonomous System Number).

Website of Akky.

www.akky.mx, and/or any website used by Akky.

Whois.

Data base system used to search existing Domain Names and its primary data, as well as to prove and verify ownership and assignation of Internet Resources; which may be consulted openly through the Website of Akky.

Services

The Services provided by Akky through the Akky's Website as the following: domain names registration transfers, queries, verifications, personalized attention, among others.

Customer

The person who acquires any of the Services offered on the Akky's Website.

User

The person who uses the Akky's website and who has not acquired any of the services offered on it.

The terms defined in this section may be used both in singular and plural.

YOUR PERSONAL DATA.

Akky will process personal identification data, contact data, labor data, academic data, observed or inferred data and proprietary and/or financial data.

Moreover, we should like to inform you that in order to comply with the purposes indicated herein, Akky will not collect or process sensitive personal data.

PRIMARY PURPOSES.

Akky will process your personal data for the following primary and necessary purposes:

- To identify and register you as a Customer of our Services;
- To provide all services and carry out all necessary activities of the legal relationship between Akky and the data holder;
- The operation, management, administration, provision and improvement of the services provided by Akky;
- To process payments and to process the billing and collection;
- Providing, to the holder of the data, access to the Website of Akky and/or the corresponding system;
- The elaboration and analysis of statistics and historical information;
- Delivery of notifications, requirements, and letters, along with the response to your requests in regards to the services offered by Akky;
- Partial or total publication of your personal data in the data system associated with Domain Names (whois).
- To respond your doubts, comments and / or requests related to our Services.

Finally, you cannot request Akky to cease from processing your information for the aforementioned primary and necessary purposes, since such processing is necessary in order to fulfill the obligations derived from the relationship between you and Akky, as well as the cases determined by Federal laws.

SECONDARY PURPOSES.

In addition, if you do not object, Akky will treat your personal data for the following additional purposes that are not necessary for the requested service, but will enable us to offer you the best service:

- To inform you of the launch or changes of Akky's new products, services, promotions and/or own offers in accordance with your interests, as well as other third-party companies, including group companies and/or business partners through phone calls, communications through emails, short messages, WhatsApp, social networks and other physical and/or electronic communication;
- The elaboration and analysis of market researches;
- To share your data with interested third parties in acquiring your domain names;
- For the application of surveys and evaluations to improve the quality of the services we offer.
- To post testimonials on the Akky's website.

Refusal to permit the use of your personal information for additional purposes will not constitute a reason to deny you the services requested or to terminate the relationship established with us.

In order to fulfill the aforementioned necessary purposes or any others required by law or the competent authorities, Akky will transfer the necessary information to the following organizations and for the following ends:

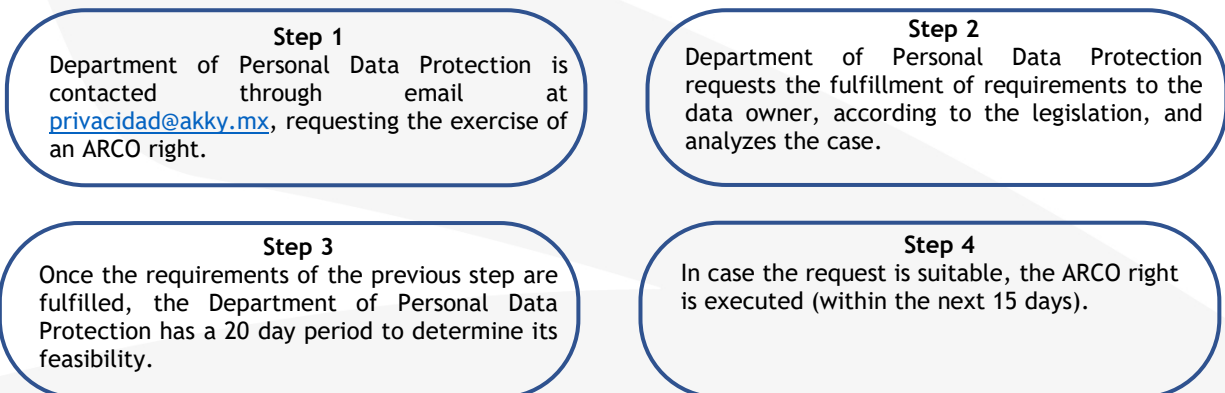

ARCO rights and/or revocation of consent.

You or your legal representative can exercise any of your rights of access, rectification, cancellation or objection (hereinafter “ARCO rights”), and revoke your consent for the processing of your personal information by sending an email to the Department of Personal Data Protection of Akky to privacidad@akky.mx requesting the ARCO rights request form.

To exercise any ARCO right, the following procedure must be completed:

- Filling of ARCO rights request form
- Data owner name and email in order to submit the response to its request.
- Documents to demonstrate its identity, or, its legal representation.
- Clear and accurate description of the personal data to which the ARCO exercise is intended
- Any other element or document that enables the location of the personal data

You can limit the use or divulgation of your personal information by sending your request to Akky to the email privacidad@akky.mx. If your request is appropriate, you will be added to Akky’s exclusion list.
